Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for the Lorain County Agricultural Society building construction and improvements project in Fiscal Year 2026. The entity to receive funding for this project is the Lorain County Agricultural Society located at 23000 Fairgrounds Road, Wellington, OH 44090.

The funding for this project will provide significant upgrades and new facilities to the 177-acre Lorain County Fairgrounds, owned by Lorain County Agricultural Society (LCAS). In addition to the requisite infrastructure improvements, specific upgrades identified for the requested Community Project Funding are the following:

- Covered Outdoor Arena with Parking Lot Improvements: The outdoor arena will be
 expanded to a competition-size covered arena for year-round shows and a staging area for
 equine events. The goal is to construct an open-sided outdoor arena with improved
 drainage attributes. A metal roof and electrical and lighting systems will support all
 planned events, regardless of weather or time of day. Dimensions of this structure will be
 135 ft. x 240 ft. (32,4000 square feet).
- Replacement of three Junior Fair Livestock Buildings: The new Beef Barn will replace three Junior Fair livestock buildings with a larger, new cattle barn. The dimensions will be 90' x 180', equaling 16,200 square feet, expanding the wash rack and fitting area.

The project has a Federal nexus because it is for the purposes authorized in Section 306 of the Consolidated Farm and Rural Development Act, 7 U.S. Code Section 1926(a).
